# Terms and Conditions of Business

## Payments

A 100% payment or a deposit of 50% (if total amount greater than GBP600) of the course fee is payable on booking the course. The booking is not confirmed until the full fee or deposit has been paid.

The final amount of the course fee and any extras must be paid two calendar months before the course is due to commence. If the course is booked within two calendar months of the start of the course, the full amount of the course is due with the booking. If the final payment is not received the booking may be deemed cancelled and Capstan Sailing School reserve the right to resell the booking.

If the student wishes to change the dates within two calendar month of the date of the start of the course, Capstan Sailing School will make every effort to accommodate the request. If it is not possible Capstan Sailing School will not be liable for the return of the deposit or any other payments.

Payments and deposits will only be refunded if the course is resold.

If for any reason Capstan Sailing School cancel the course and alternative dates cannot be arranged a full refund of course fees will be made, but otherwise shall have no liability to the client.

## Age Limits

Capstan Sailing School cannot accept students under the age of 18 unless accompanied by a parent or guardian.

There is no upper age limit, but students should satisfy themselves that they are fit and able to join their chosen course.

## Insurance

Our yachts are fully insured against accidents and third party liability, but responsibility is not accepted for personal accidents, damage or loss due to your negligence. Unnecessary equipment damage and losses attributed to your carelessness will be paid for by you at replacement price – fair wear and tear accounted for. You are strongly recommended to arrange personal insurance cover for your own cancellation, bodily injury and personal liability.

## **Students' responsibilities**

Students have the following responsibilities:

- To ensure that they do not take any action which jeopardises the safety of fellow clients, skippers or boats.
- To observe the rules of Customs and Excise and any other authorities to which they may become subject.
- To observe the standards of personal conduct which will not be considered offensive by fellow crewmembers or neighbouring vessels.
- In the event of unacceptable behaviour, Capstan Sailing School reserves the right to terminate the offending clients course. Fees will not be refunded.
- **To inform the school of any known medical conditions.**

## **RYA Certificates**

Capstan Sailing School has high standards of instruction and applies RYA guidelines on the issue of certificates. Certificates will not be issued if, in the opinion of the instructor, the student has not reached the necessary standard.

## **Health**

Sailing is an activity sport and it is the responsibility of the student to ensure that they are healthy and fit to sail. Please check with your Doctor if you are in any doubt. If for whatever reason, the skipper has to put a student ashore or administer medical aid, Capstan Sailing School or its skippers or other employees accept no liabilities.

## **Late arrivals**

Capstan Sailing School will make every effort to revise sailing timetables to accommodate late arrivals. However, if such delays affect other students' courses, the skipper may decide to sail without the delayed student. In such cases, no refund will be given.

## **Own Boat Instruction**

In own boat instruction, all the above conditions apply. The owners will also be required to:

- Ensure that the yacht is equipped appropriately and is maintained in a proper and seamanlike condition for the intended sailing area.
- Ensure the yacht is fully insured for the duration of the instruction.
- Provide all travelling and out of pocket expenses for the Instructor from Brighton or their home, whichever is the least.
- Retain responsibility for the safety of the yacht throughout. The instructor will not take on the skipper's responsibilities, he will however advise the owner on all safety matters.
- Capstan Sailing School will make every effort to ensure that the course takes place as planned. However, if in the instructor's opinion weather conditions, safety, or any other consideration renders it imprudent to continue, then the instructor's decision is final.
- Capstan Sailing School does not accept liability for the consequence of delay or

cancellation in any circumstances.

## **Force Majeur**

In the event of non-performance, partial performance or delay resulting wholly or partly from any force majeure or occurrence or any circumstance whatever beyond the control of Capstan Sailing School including (without limitation) the acts or omissions of third parties, labour difficulties, weather conditions, technical breakdown or accident to any vessel or any part of it, natural disaster or any act of authority, the Capstan Sailing School shall use reasonable endeavours to continue to perform the booking but otherwise shall have no liability to the client. The client shall be liable to pay such part of the price as applicable to that part of the booking which has been performed (if any), and all expenses connected with it, and anything in excess already paid by the client shall be refunded. Capstan Sailing School determination of the applicable part of the price and the connected expenses shall be conclusive in the absence of manifest error.

## **Complaints**
